## **Deluxe Photo Love Story**

To be played during the reception. Narrating Family Photos, the Bride and Groom they tell the story up to now, and set the stage for the story of their lives together. They tell the story of their lives growing up, how they met, the story of their love, and how he popped the question Up to 250 photos set to the music of your choice, with professional titles and animated effects and green screen effects, plus Interviews and special individually recorded messages from the bride and groom to each other. Price includes scanning, color correcting, basic photo restoration if needed, animation, filming interviews and green screen elements, chromakeyed composite animations, and DVD production.

## **Scenic Love Story**

To be played during the reception. We take the Bride and groom to a beautiful outdoor setting and let them tell the story of their lives up to now, and contemplate about the story to come. They tell the story of their lives growing up, how they met, the story of their love, and how he popped the question. We also record special messages from the bride and groom to each other. A \$200.00 non-refundable retainer is required to secure date.

If the wedding is cancelled or the date is changed, the retainer is forfeited. An additional \$100.00 non-refundable retainer will be required to secure a new wedding date.

If the retainer is paid by check and the check is returned, the contract is void and the date is no longer secured.

It is the sole responsibility of the client to secure permission of the church, synagogue or other officials to film the ceremony. The deposit is non-refundable if such officials prevent filming.

Practically Righteous Studios will take utmost care to produce a tape of good quality. However, we will not be held responsible for circumstances beyond our control, including but not limited to power failure, equipment malfunction, and defective tape stock or client misuse of equipment. If filming is prevented due to such occurrences, all money paid will be refunded.

Practically Righteous Studios makes no guarantees, either expressed or implied, in regard to aesthetic qualities of the completed video.

Practically Righteous Studios reserves the right to terminate contract for any reason at any time. Should Practically Righteous Studios terminate the contract, all monies paid will be refunded.
